A portion of the summer reading camp funds can be carried over and applied to iReady. Title 1, 2 and 4 funds can be used for a portion of the purchased. CFO Ryan Nelson is asking for approval of up to \$27,314.54 for these programs, with the reallocation of eligible funds from the 2020-21 budget to offset the total program costs. A motion was made, seconded by Angie Kern, to approve up to \$27,314.54 for the universal screener programs. All in favor. None opposed. No abstentions. Motion carried.
