Call to order

Reopening Plan Summary

Casey Harris provided an overview of the Reopening Plan. He reported that additional changes came from the State on Friday, July 24, and more changes are expected, meaning that this plan may need to be revisited to address additional mandates from the State. The document provides a comparison between March-June and this school year's plan B remote learning. UCA is still waiting to receive guidelines from NC Department of Public Instruction on attendance tracking. Four of our maintenance/custodial staff will assist with driving/monitoring of busses. If K-6 families want to change decision from virtual to face-to-face, they cannot change during a grading period; changes can be requested to start at the beginning of a new grading period.

HR Position

HR Consultant Shawn Straub is recruiting for this HR coordinator position and has already received at least 13 applications already. Greg Zephir made a motion, seconded by David Van Derveer, to authorize

hiring a full-time HR coordinator that will report to the interim superintendent and serve as a primary contact to our HR consultant, Alt HR Partners. All in favor (0 Opposed; 0 Abstained). Motion carried.

EC Position

A new 1:1 Exceptional Children (EC) position is required at the elementary school. Casey reported that he will apply for special State reserve when application period opens August 1. Kristian Allen make a motion, seconded by Angela Kern, to hire the new full-time EC assistant position needed.
